

**End User License Agreement**  
**TERESA Database**  
(<http://www.teresa-db.eu/>)

By signing this document the user, he or she who will make use of the database or the database interface, agrees to the following terms.

With database, we denote both the actual data as well as the interface to the database.

### 1. Commercial use

The user may not use the database for any non-academic purpose. Non-academic purposes include, but are not limited to:

- proving the efficiency of commercial systems
- training commercial systems
- creating military applications
- developing governmental systems use in public spaces

### 2. Distribution

The user may not distribute the database or portions thereof in any way, with the exception of using small portions of data for the exclusive purpose of clarifying academic publications or presentations. **Only data from subjects who gave consent to have their data used in publications and presentations may be used for this purpose.** Note that publications will have to comply with the terms stated in article 4.

### 3. Access

The user may only use the database after this End User License Agreement (EULA) has been signed and returned to the iBUG Group at Imperial College London. The signed EULA should be returned in digital format by uploading it to the website when requesting account at:

“(Portions of) the research in this paper uses the TERESA Database collected in the scope of TERESA project financially supported by the European Community’s 7<sup>th</sup> Framework Programme (FP7/2007-2013) under Grant agreement No. 611153 (TERESA)”.

The user will send a copy of any document or papers that reports on research that uses the TERESA Database to Prof. Maja Pantic or to <publications@teresa-db.eu>.

#### **5. Academic research**

The user may only use the database for academic research.

#### **6. Warranty**

The database comes without any warranty. The iBUG Group at Imperial College London cannot be held accountable for any damage (physical, financial or otherwise) caused by the use of the database. The iBUG Group at Imperial College London will try to prevent any damage by keeping the database virus free.

#### **7. Misuse**

If at any point, the administrators of TERESA database and/or iBUG Group at Imperial College have a reasonable doubt that the user does not act in accordance to this EULA, he/she will be notified of this and will immediately be declined the access to the database.
